The purpose of this modification is to:

1. provide incremental funding in the amount of **\$36,021.00**, thereby increasing the obligated amount of the contract from \$533,227.00 to **\$569,248.00**.

Accordingly the contract is modified as follows:

1) Refer to Section B.3, "CONSIDERATION AND OBLIGATION- COST PLUS FIXED FEE (JUN 1988) ALTERNATE 1 (JUN 1991)", paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount currently obligated by the Government with respect to this contract is **\$569,248.00**, of which the sum of **\$527,081.47** represents the estimated reimbursable costs, and of which **\$42,166.53** represents the fixed fee."
