Subject: DEMAND FOR INFORMATION

This is to inform the Commission that a Demand for Information (DFI) will be issued on or about January 23, 2008, to Mattingly Testing Services, Inc. (Mattingly Testing). On November 7, 2007, the NRC began an inspection and investigation of Mattingly Testing's licensed activities and the information obtained so far has raised concerns that warrant issuance of this DFI while the inspection and investigation activities continue. The NRC requires information to evaluate and determine the appropriateness of Mattingly Testing's licensed material program at temporary job sites. The NRC also needs information to evaluate the depth and completeness of Mattingly Testing's work environment and its determination that it maintains an environment where employees can raise safety concerns without fear of retaliation. Specifically, the NRC needs additional details relative to the establishment, implementation and maintenance of a program designed to provide and support such a work environment.

After reviewing the licensee's response to the DFI, the staff will determine whether further action is necessary to ensure compliance with regulatory requirements.

It should be noted that the licensee has not been specifically informed of the enforcement action. The schedule of issuance and notification is:

The licensee has twenty days from the date of the DFI in which to respond.

The Montana State Radiation Control Program will be notified.
