Dear Ms. Curran:

I am responding to your letter of August 25, 2006, by which you submitted to the Nuclear Regulatory Commission (NRC) a petition for rulemaking (PRM) on behalf of the Massachusetts Attorney General (AG) concerning the environmental impacts of the high-density storage of spent nuclear fuel in spent fuel pools. You requested that Title 10 of the *Code of Federal Regulations* (10 CFR), Part 51, be amended. We docketed your petition as PRM-51-10 and published a notice of receipt and request for public comment on PRM-51-10 in the *Federal Register* on November 1, 2006 (71 FR 64169).

The Deputy AG of the State of California in a letter dated March 16, 2007, submitted a similar PRM incorporating by reference the facts and legal arguments set forth in PRM 51-10. Because of the similarities of PRM-51-10 and PRM-51-12, we evaluated the two petitions together.

We received 1,676 public comments on the two petitions, with 1,602 of these being nearly identical form e-mail comments supporting the petitions. Sixty-nine other comments also supported the petitions. These comments were submitted by States, private organizations, and members of the U.S. Congress. Two letters from the Nuclear Energy Institute (NEI) opposed the petitions, and three nuclear industry comments endorse NEI's comments.

Based upon our review of the petitions, we have determined that the studies upon which you rely do not constitute new and significant information. We further determined that our findings related to the storage of spent nuclear fuel in pools, as set forth in NUREG-1437, *Generic Environmental Impact Statement for License Renewal of Nuclear Plants*, May 1996, and in Table B-1, of Appendix B to Subpart A of 10 CFR Part 51, remain valid. Thus, the NRC has met, and continues to meet, its obligations under the National Environmental Policy Act. Accordingly, we are denying both PRMs.
