Dear Ms. Ullrich,

In January 2, 2008, Capintec, Inc. received a series of invoices from the NRC, for the period 2004 through 2007, stating "administrative billing errors" for small materials licenses.

In response to significant additional fees, I have reviewed the usage requirements listed under the above references licenses, and it appears that Capintec has duplicate licensing requirements.

License 37-14179-03

Item 7.D. states "Sealed sources"

Item 9.D. states

"For testing and calibration of instruments. For distribution to persons authorized to receive the license material to terms and conditions of a specific license issued by the Nuclear Regulatory Commission or an Agreement State."

There is no limitation or exclusion of medical facilities on License # 37-14179-03.

Item 7.A. states "Sealed sources..."

## Item 9.A. states

authorized to re-distribution of sealed sources to "persons licensed pursuant to 10 CFR 35.65", or to medical facilities.

Capintee distributes sealed sources only, which are approved by the NRC or Agreement State, and are used for quality assurance checks by end users. We do not distribute unsealed radiopharmaceuticals or other unsealed radioactive materials.

Therefore, I requesting an amendment to license # 37-14179-03, item 9.D to read as follows:

"For testing and calibration of instruments. For distribution to persons authorized to receive the license material to terms and conditions of a specific license, including those licensed pursuant to 10CFR 35.65 (or current reference), issued by the Nuclear Regulatory Commission or an Agreement State."

This would then eliminate the need for license 37-14179-02MD, and also reduce the fees now associated with the requirement for two separate distribution uses.

Please note that all other NRC license conditions and Radiation Safety program remain the same as stated in the Renewal letter dated August 31, 2004 and letter dated May 26th, 2006 for license # 37-14179-03.
