REMARKS: IP 71111.01 (Adverse Weather Protection) has been revised as a part of the 2007 Reactor Oversight Process (ROP) Realignment to add external flooding review, formerly included in IP 71111.06, "Flood Protection Measures." The document has also been revised to address a feedback form.

IP 71111.05AQ (Fire Protection (Annual/Quarterly)) has been revised as part of the 2007 ROP realignment to reduce the sample size to 16 and the

resource hours to 35 hours. The revision also responds to a feedback form.

IP 71111.06 (Flood Protection Measures) has been revised as part of the 2007 ROP realignment to shift the external flooding review to IP 71111.01, “Adverse Weather Protection” and to make minor editorial revisions.

IP 71111.07 (Heat Sink Performance) has been revised as part of the 2007 ROP realignment to change the frequency of the biennial part of the procedure to a triennial, provide more specific inspection guidance, make the procedure more effective and efficient, and incorporate minor editorial comments.

IP 71111.12 (Maintenance Effectiveness) has been revised as part of the 2007 ROP realignment to clarify the level of effort section to clearly state that the samples are not required on a quarterly basis.

IP 71111.13 (Maintenance Risk Assessments and Emergent Work Control) has been revised as part of the 2007 ROP realignment. The references were updated to reflect the deletion of TI 2515/165, authorized in Change Notice 07-028, and to incorporate minor editorial revisions.

IP 71111.15 (Operability Evaluations) has been revised as part of the 2007 ROP realignment to add inspection guidance regarding verifying that a licensee has correctly implemented 10 CFR 50.59 regulatory requirements if operability evaluations warrant that such 50.59 evaluations be performed.

IP 71111.17 (Evaluations of Changes, Tests, or Experiments and Permanent Plant Modifications) has been revised as part of the 2007 ROP realignment to combine the previous IP 71111.02, “Evaluations of Changes, Tests, or Experiments,” and the biennial portion of IP 71111.17, “Permanent Plant Modifications” into a single inspection procedure as a triennial inspection.

IP 71111.18 (Plant Modifications) is issued as part of the 2007 ROP realignment to combine the contents of IP 71111.17A, “Permanent Plant Modifications, Annual” and IP 71111.23, “Temporary Plant Modifications,” into one inspection procedure.

IP 71111.20 (Refueling and Other Outage Activities) has been revised as part of the 2007 ROP realignment to: (1) clarify when outages should be addressed via IP 71111.20 versus IP 71153, “Followup of Events and Notices of Enforcement Discretion” and (2) clarify the estimate of annual inspection resources for non-refueling and forced outages.

IP 71111.21 (Component Design Bases Inspection) has been revised as part of the 2007 ROP realignment to: (1) provide flexibility in selection of samples in categories of components, operator actions, and operating

experience; (2) generally preclude re-inspection of items previously inspected by Safety System Design and Performance Capability (SSDPCs) and Component Design Bases (CDBIs) Inspections; and (3) perform CDBIs on a triennial cycle.

IP 71111.02 (Evaluations of Changes, Tests, or Experiments) has been deleted. Provisions are included in the revised IP 71111.17.

IP 71111.23 (Temporary Plant Modifications) has been deleted. Provisions are included in IP 71111.18.
