## Rick:

This is in reference to your request for our review of the Model No. ANF-50 package, authorized by German Certificate of Approval No. D/4365/AF-96. During my preliminary review, I have identified two omissions that should be addressed before we can start our technical review.

- (1) The application does not appear to include engineering drawings of the packaging. There is a detailed sketch (AREVA Drawing AD-003750-001), however, the sketch does not include detailed information such as dimensions, tolerances, weld design and testing, and materials of construction. I note that a list of detailed drawings is included in the table of contents for the Safety Report (page 3 of 4), however, these drawings themselves were not included.
- (2) The application has a "Note" on the front page of the documents that indicates that the documents, in their entireties, cannot be released to the public. We need an affidavit that identifies specific information that should be withheld as company proprietary, along with the basis for withholding (see 10 CFR 2.390). Otherwise, a letter from the owner of the documents indicating that they may be released, is needed.

We are therefore terminating our review. However, we will retain the documents, and upon receipt of the above information, we will restart our review. Please don't hesitate to contact me should you have questions or if you would like to discuss this matter.
