Reference 1 requested a change to the Completion Time for Technical Specifications 3.8.1, Condition B for Comanche Peak Steam Electric Station (CPSES), herein referred to as Comanche Peak Nuclear Power Plant (CPNPP). References 2 and 3 contained requests for additional information regarding Reference 1. Reference 4 is Luminant Generation Company LLC (Luminant Power, previously known as TXU Power) combined response to the two NRC requests for additional information.
