Subject: Schedule for Piping Design Document Review

In letters dated January 11 and January 14 Westinghouse revised the piping design acceptance (DAC) criteria and the COL information item related to ASME Code piping and component design document review. The AP1000 Design Control Document does not include a schedule to close or resolve the piping DAC and the understanding is that DAC are not required to be closed or resolved prior to the NRC issuing of a COL. The COL information item identifies the review of piping and component as a COL holder item and the Bellefonte COL application included conforming changes to add a license condition for the review of these items.

It is the intention of Westinghouse that design documents related to the DAC and COL information item will be available for NRC review during the period scheduled for the NRC review of the design certification amendment. It is expected that information will be available for NRC review to permit the resolutions, closure, or removal of the DAC and COL information item. The piping information will be in the form of piping analysis packages of risk significant lines that will be available for NRC review. The ASME component information will be design specification and design reports available for NRC review. The following provides the schedule information to support these efforts.

•	The first piping analysis package provided for NRC audit to assure that there is a mutual understanding about the scope of the review.	April 2008
•	Remainder of risk significant ASME Code Class 1 lines available for NRC review to resolve DAC.	August 2008
•	Risk significant ASME Code Class 2 and 3 lines available for NRC review to resolve DAC.	December 2008
•	Design specifications available for major ASME components	February 2008
٠	As-designed design reports available for major ASME Components	July 2008
٠	Design specifications available for auxiliary equipment and valves.	July 2008
