Dear Mr. Lynch:

As part of Wisconsin's transition to an agreement state with the Nuclear Regulatory Commission, the Department of Health and Family Services (DHFS) has asked certain licensees to provide financial assurance documents to the state (ex: letter of credit, escrow agreement, letter of intent) that could replace those currently held by the NRC. Effective February 6, 2008, the DHFS has approved financial assurance instruments that meet the requirements of s. HFS 157.15, WI Administrative Code for the following radioactive material licensee:

Shortly after Wisconsin became an agreement state in August 2003, CERAC, JP Morgan Trust Company (escrow agent), the NRC and the DHFS signed a Modification of Escrow Agreement that changed the beneficiary of the CERAC decommissioning fund escrow account from the NRC to the WI DHFS. The new financial assurance effective February 6, 2008, consisting of a letter of credit paired with a standby trust, replaces the Modification of Escrow Agreement and the CERAC financial assurance instrument currently held by the NRC.

This is the final Wisconsin licensee impacted by the agreement state transfer of authority to complete the process of replacing their financial assurance. Please contact me with any questions.
