Part 5 – Emergency Plan

Explanatory notes regarding the Emergency Plan and Supplemental Information

The William States Lee III Nuclear Station (Lee Nuclear Station) Combined License Emergency Plan consists of a basic plan and ten appendices. The basic plan follows the format of NUREG-0654 and provides detailed information regarding each of the sixteen *Planning Standards* and associated *Evaluation Criteria*. The ten appendices that follow provide additional detailed information on various aspects of the Emergency Plan. Supplemental information includes the detailed evacuation time estimate report and state and local emergency planning documents. These state and local emergency planning documents include current versions of state and local plans, as well as proposed changes to these plans and proposed new plans to address the Lee Nuclear Station. The following table delineates documents included as the Emergency Plan and those documents found in Supplemental Information. Emergency Planning Inspections, Test, Analyses, and Acceptance Criteria (ITAAC) are included in Part 10 of the COLA.
