DEAR SECRETARY, NRC

NO ONE KNOWS WHAT THE CONSEQUENCE'S WOULD BE A
HUNDRED YEARS FROM NOW, IF THE WASTE IS IMPORTED TO
OUR NATION. I LOOK BACK AT WHAT HAPPENED WHEN ATOMIC
