General Comment: The emphasis in this regulation should be on source strength alone and not source activity. Confusion between the two often leads to misadministrations. In the following paragraph of 10 CFR 35.40, "nominal activity per source" should be replaced by "nominal or actual strength per source". Our treatment plans are calculated with the manufacturer's nominal strength decayed to the actual time of the implant. Asking for the nominal activity is just wrong, and asking for the nominal strength unnecessarily discourages use of a properly decayed value. Some manufacturers calibrate and state their nominal strength at dates and times far removed from the time of use making the use of a nominal strength nearly meaningless.
