

The purpose of this modification is to) Exercise Option Year One to extend the period of performance from March 19, 2008 through March 20, 2009; 2) Increase the ceiling amount of the contract by \$125,724.96, from \$122,063.04 to \$247,788.00; 3) Increase the amount funded in the contract by \$125,724.96 from \$101,540.00 to \$227,264.96; and 4) Incorporate the attached Instrument of Assignment of Claims and Far Clause 52.232-23. Accordingly the Contract is modified as follows:

1. Section B.1 CONSIDERATION AND OBLIGATION-FIRM FIXED PRICE, is deleted and substituted with the following in lieu thereof:

"(a) The firm fixed price of this contract for the basic contract through Option Year 1 is \$247,788.00. (b) The amount currently funded with respect to this contract is \$227,264.96."

2. Section C.8 DURATION OF CONTRACT PERIOD, is deleted and substituted with the following in lieu thereof:

"This contract shall commence on March 19, 2007 and will expire on March 20, 2009. The term of this contract may be extended at the option of the Government for an additional three years."


