By Order, dated July 2005, as modified by orders dated February 9, 2006 and July 6, 2007,¹ the Pre-License Application Presiding Officer (PAPO) Board required that after a Licensing Support Network (LSN) participant's initial certification of its LSN collection, and after the Department of Energy (DOE) certifies its LSN document collection, each LSN participant shall, on or before the first of each month, certify on a monthly basis that it has duly supplemented its LSN collection with any additional documentary material discovered or created after the time of its initial certification. The NRC Staff last filed a certification of the supplementation of its LSN collection on January 31, 2008.
