Dear Secretary, Nuclear Regulatory Commission

I am opposed to plans by Salt Lake City-based EnergySolutions to import 20,000 tons of waste from Italian nuclear plant cleanups. An estimated 1,600 tons would be buried at the company's low-level radioactive waste disposal site in Tooele County, UT. The limited capacity for storing this type of waste nationally should be a major concern. We should deal with our own waste and let Italy deal with theirs. I am opposed to transporting this waste internationally and across the United States. I am also very opposed to disposing of this waste in Tooele County, Utah. The space available at that facility should be reserved for nuclear waste generated in the United States. We should not fill it up with waste from other countries, which puts us in the difficult position of what to do what it is full.

As a citizen of Utah, I feel we do should not let EnergySolutions gain be Utah's and the United States loss.
