Subject: Application for Amendments to Specific Import License IW022 and
Specific Export License XW012

Dear Mr. Moore:

Perma-Fix Northwest requests a minor license amendment to the above specific import license to authorize the import of potentially radioactively contaminated material from Canada to Perma-Fix Northwest in Richland, Washington for processing under Perma-Fix Northwest's Washington licenses. Perma-Fix Northwest also requests a minor license amendment to the above specific export license to authorize the export of radioactive waste generated from this processing to the extent necessary back to Canada.

The only change that is asked for in the amendment request for IW022 is to add Zircotec Precision Industries, Inc. as an additional Canadian supplier. The only change to XW012 is to add Zircotec Precision Industries, Inc. as a foreign consignee should there be a need to send imported material from Zircotec Precision Industries, Inc. back to Canada as provided for in XW012. All other conditions of these existing licenses are unchanged.

Form 7 is attached. We are enclosing a check in the amount of \$1540 to address the fees for two applications specified in 10 CFR 170.31, Category 15 R for minor amendments in accordance with the February 21, 2008 email from Steve Dembek.
