Gentlemen:

The following information is provided concerning a change of ownership for NRC byproduct materials license number 13-32537-01 effective December 28, 2007 (the number items follow the format of NUREG 1556, Vol. 9 (Rev. 2, 2008))

1. The name of the licensee continues to be Heart Partners of Indiana, LLC (HPI). Effective December 28, 2007, HPI sold 100% of its membership interests to Clarian Health Partners, Inc., but will continue to do business under the name of Heart Partners of Inc. The licensee contact is Vincent Bournique, M.D., Medical Director (765-298-4427).
2. A license amendment request was submitted February 1, 2008 requesting the removal of Dr. Jetty as an Authorized User and Radiation Safety Officer and requesting that Dr. Vincent Bournique, a currently listed Authorized User, be recognized as the Radiation Safety Officer. There are no other changes in personnel or duties that relate to the licenses program.
3. There are no changes in location, facilities, equipment or procedures that relate to the licensed program. The President and CEO of Clarian Health Partners, Inc. is Daniel F. Evans, Jr.
4. The surveillance program (surveys, wipe tests, quality control) was in compliance with appropriate NRC regulations prior to and at the time control was transferred.
5. All records concerning the safe and effective decommissioning of the facility have been transferred to Clarian Health Partners, Inc.





