SUMMARY

In our telephone conversation, we discussed the following matters and the need for submitting the following additional information:

I related that we can not authorize the licensee to release for unrestricted use, their former storage facility located at 618 S. Blitzen Lane, Santa Claus, Indiana, without the licensee providing additional information to confirm the proper disposition of the material stored there and to confirm that the vacated facility meets NRC criteria for release for unrestricted use. In that regard,

Please provide the following information:

1. The date both gauges referenced in your letter dated January 14, 2008, were removed from your former storage facility located at 618 S. Blitzen Lane, Santa Claus, Indiana, **and** to which of your other two storage facilities the gauges were transferred;
2. A statement from you, confirming that you have never possessed any leaking sealed sources at 618 S. Blitzen Lane, Santa Claus, Indiana, based on routine leak test data for sources you have possessed at that storage facility, if indeed that be fact; and
3. Confirmation that no licensed material remains at the facility located at 618 S. Blitzen Lane, Santa Claus, Indiana.


