Re: Amendment to Location of Nuclear Gages

To Whom It May Concern:

Please note this is a request to amend our existing license. We have a new address for where our nuclear gages are to be stored. I have included an Application, and a floor plan showing the location of the gages in the office.

The following is our storage plan:

The nuclear gages will be stored in the closet as per the diagram. The 1st barrier is a latch and padlock on the door of the closet. The RSO is the key holder for the office. Each of the Nuclear certified technicians also has a key to the padlock.

The 2nd barrier is 3 latches that will be screwed to the middle shelf and to the bottom shelf of the closet. Reinforced cables will be threaded through each of the nuclear gage cases and through each of the 3 middle shelf latches, then padlocked at the bottom latch. When a nuclear certified technician takes a gage from the closet, they will also take the cable and padlock from the closet to use as the 2nd barrier in their vehicle.

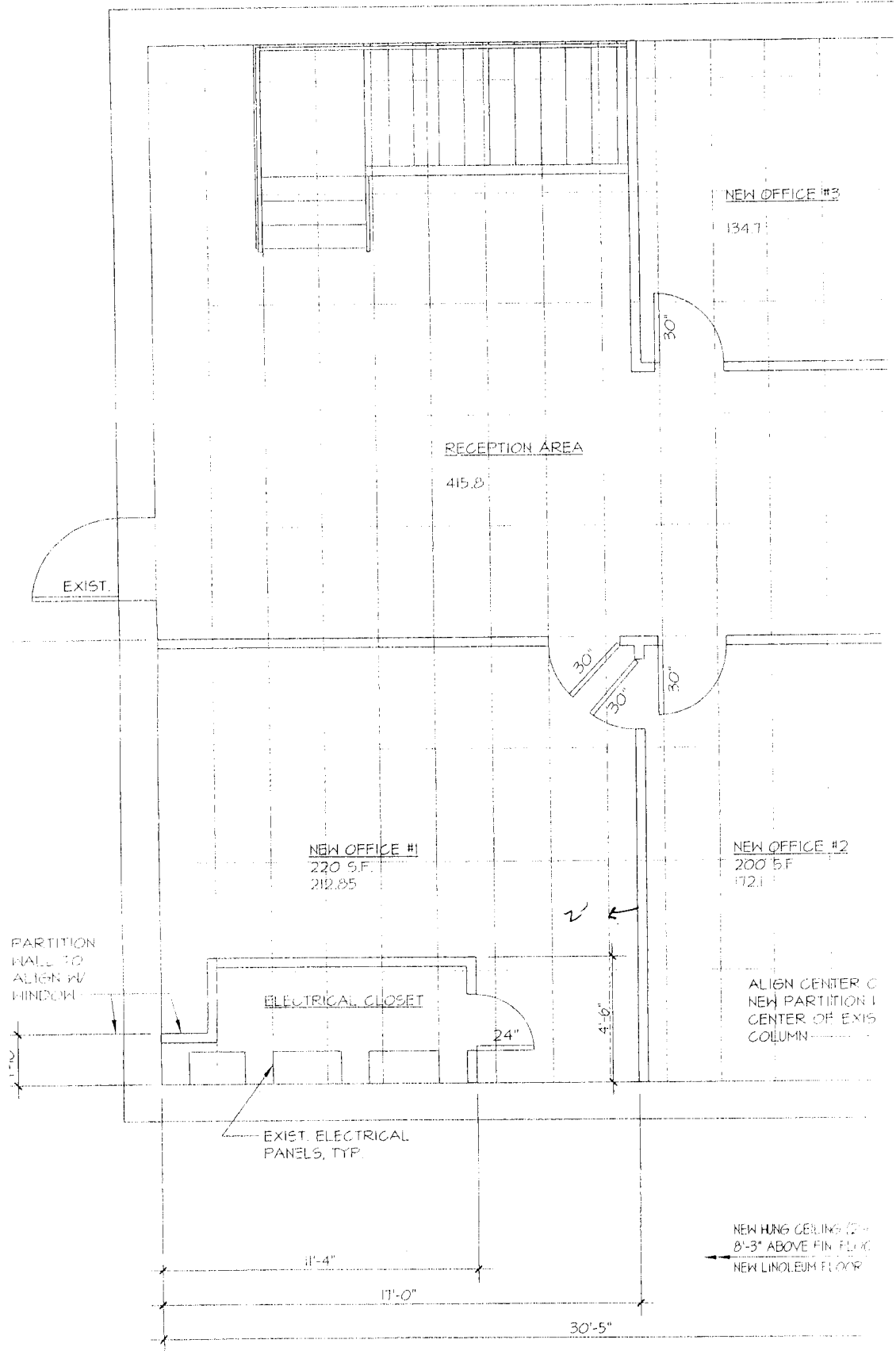

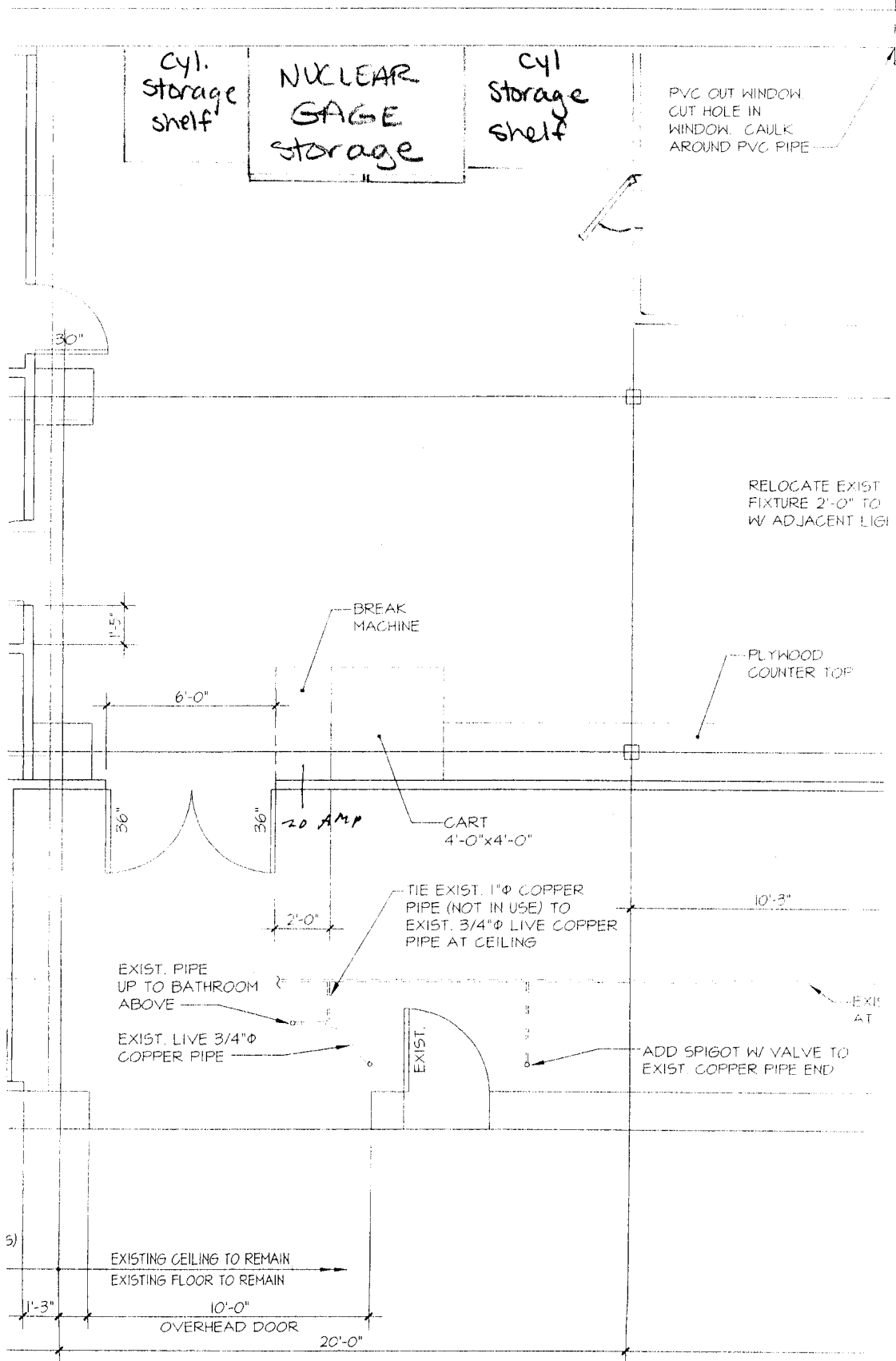

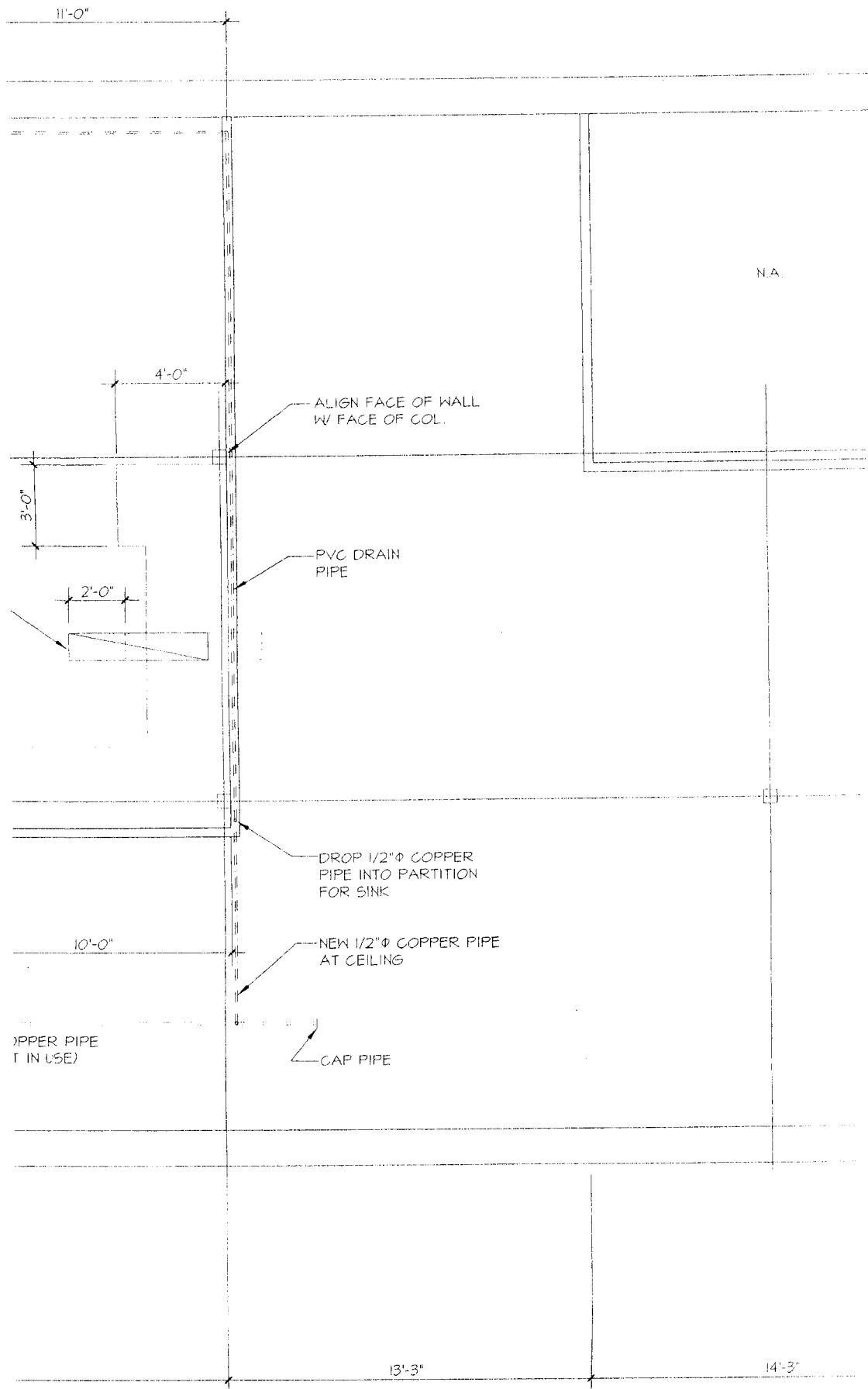
