Add the following to License Section 8.

Any byproduct material with atomic numbers 1 through 98	Sealed Sources	Not to exceed 1 curie per source and 2 curies total per shipment

Authorized Use

Receive non-leaking sealed sources from clients for evaluation. Based on the results of the evaluation the sources would either be recycled through licensee-to-licensee transfer or disposed through a licensed radioactive waste broker. Results of sealed source leak tests will be required to accompany each shipment. Sources will not be in our possession for more than 90 days.

The possession of licensed material will be restricted so that at no time will a quantity of radioactive material in the form of non-leaking sealed sources be possessed in excess of the quantity that requires decommissioning funding in accordance with 10 CFR 30.35(d).
