This is a request pursuant to FOIA for copies of all records created or received by the U.S. Nuclear Regulatory Commission (“NRC”) with respect to environmental investigations of the above-referenced Site. This request includes, but is not limited to:

- records of investigations regarding any contaminants in soil, groundwater or abandoned buildings or equipment (e.g., tanks, containers) at or emanating from the Site;
- records regarding data on Site contaminants, including but not limited to radioactive materials and other hazardous substances, manufactured, used, stored or disposed of at the Site and data on contaminants in surface or subsurface soil and surface water or groundwater at or emanating from the Site;
- NRC memoranda regarding reviews of submissions regarding environmental investigation(s) of the Site;
- NRC correspondence with the Maryland Department of Environment, the U.S. Environmental Protection Agency, the former or current Site owner/operators and/or their consultants regarding environmental investigations or environmental assessments of the Site;
- records describing Site operations, including any drawings or other documents describing the placement of manufacturing and storage facilities, tanks, utilities and other equipment at the Site; and


