

The purpose of this modification is to:

- (1) Exercise Option Year 1, thereby increasing the total ceiling amount of the contract by \$328,536.00, from \$225,000.00 to \$553,536.00;
- (2) Provide funding in the amount of \$328,536.00, thereby increasing the total award and obligated amount from \$225,000.00 to \$553,536.00; and,
- (3) Revise the period of performance to reflect option year 1.

Accordingly, the following changes are hereby made to the contract:

1. Box 26, Total Award Amount, (Standard Form 1449) is revised to read as follows:

**\$553,536.00**

2. Section B.4, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), is revised to read as follows:

"The contract shall commence on **August 2, 2007** and will expire on **May 1, 2009**. The term of this contract may be extended at the option of the government for an additional **3** years."
