## Dear NRC:

The license application by Energy Solutions should be denied. There is no place or technology to isolate this hazardous radioactive waste that would fill up existing disposal capacity. It would be extremely dangerous to transport the 20,000 tons of radioactive waste across the ocean to U.S. ports. And further travel across the U.S. to Utah for burial, which hasn't accepted nuclear waste for burial yet, would be equally dangerous. We don't even have a solution for safe burial of our own nuclear industry or weapons waste. Why take more from Italy?

I am very concerned about the lack of regulartory controls of the waste that Energy Solutions could consider dumping in Solid Waste Dumps in TN. Nor are there sufficient controls for considering some waste as "recycled" or "released" for use as if it is NOT radioactive.

License for processing and disposal of such large scale importation of nuclear waste must be denied. We must consider the safety and health of the American people.
