Dear US Nuclear Regulatory Commission,

Thanks to the work of Nuclear Information and Resource Service, I've been informed of the project of nuclear waste import from Italy.

In no way, transporting nuclear waste all around the world can be a solution.  
As I'm from France, you may imagine that I would prefer the French Area to do the job.  
Not at all, we are against reprocessing of spent fuel from old Italian NPP in the French reprocessing plant in La Hague too (and against reprocessing in general).  
Problems has to be solved locally as long as possible.  
Of course, as no solution has been found for HAW (and no good solution for LAW), the only solution indeed, is to stop producing nuclear waste and to stop NPP, as Italy did.  
Nevertheless, Italy can't get rid of their responsibilities by spreading nuclear waste in other countries.

So please refuse the license applications IW023 and XW013.
