Dear Nuclear Regulatory Commission:

I urge you to deny the license applications Nos. IW023 and XW013 (Federal Register Volume 73, Number 28, 2/11/08) made by EnergySolutions, the operator of commercial nuclear waste dumps in South Carolina and Utah, to import radioactive waste through the Ports of Charleston and New Orleans.

The United States of America should never import radioactive waste from other countries; we have not found a solution to the disposal of our own nuclear waste, and it is unthinkable to allow Italy or any other nation to process, incinerate, "recycle," or transport their waste here.

I would appreciate a response to this email, and I request to be informed of your decision regarding this highly dangerous application.
