Dear Chairman Klein:

Because your agency has a critical role in national radiation protection, I am sending the Commission a special invitation to attend the 2008 National Conference on Radiation Control being held May 19 – 22, 2008 in Greensboro, North Carolina. Numerous federal organizations are providing speakers on specialized topics. Your presence would encourage and support state and federal technical staff as they discuss the many issues facing radiation control programs. Also, it would convey the importance that you and your organization place on a strong partnership with state, tribal, and local government agencies in the field of radiation protection

On behalf of the Board of Directors of the Conference of Radiation Control Program Directors (CRCPD), I would also like to invite any of the Commissioners attending the Annual Conference to a special luncheon for informal discussion of state and federal radiation protection issues. We will establish a date for the luncheon based on your availability.

As you know, the CRCPD hosts this annual conference. CRCPD's primary membership is made up of radiation professionals in State and local government that regulate the use of radiation sources and others with an interest in radiation protection. CRCPD's mission is "to promote consistency in addressing and resolving radiation protection issues, to encourage high standards of quality in radiation protection programs, and to provide leadership in radiation safety and education."
