The purpose of this modification is to provide funding in the amount of \$70,000, thereby increasing the obligated amount of the contract from \$726,623 to \$796,623. Accordingly, the contract is modified as follows:

1. Section B.2, Consideration and Obligation-Delivery Orders (JUN 1988), the first sentence in paragraph (b), as modified in Modification No. 10 is deleted and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$796,623."
