To whom it may concern:

We write to inform you of the impending transaction whereby Trinity Health – Michigan doing business as Mercy General Health Partners (“Trinity”), will become the sole corporate member of Hackley Health Systems, Inc. (“Hackley”), the parent company of NRC licensee Hackley Hospital (Materials License # 21-04125-01)(the “Transaction”). Under the Transaction, there will be no change in Hackley Hospital’s corporate identification number nor are there current plans to change Hackley Hospital’s name. Additionally, Hackley Health Systems, Inc. (the parent company of Hackley Hospital), will remain the same legal entity with the same tax identification number. As noted above, the only change involves Trinity becoming the sole corporate member of Hackley.

This letter confirms that the Transaction will not result in a change in Hackley Hospital’s personnel, duties, organization, location, facilities, equipment, and procedures related to the licensed program. Likewise, the current status of the Hackley Hospital’s surveillance program is, and following the Transaction, will remain consistent with prior filings. All documents relevant to the decommissioning of the Hackley Hospital will remain in the possession of the Hackley Hospital. Furthermore, Hackley Hospital will continue to abide by all constraints, conditions, requirements and prior commitments.

In the event that the NRC considers the Transaction a change of control requiring NRC consent, please consider this letter to be a request for the NRC’s written consent.
