Enclosed are five (5) copies of the report "BWRVIP-87, Revision 1: BWR Vessel and Internals Project, Testing and Evaluation of BWR Supplemental Surveillance Program Capsules D, G, and H," EPRI Technical Report 1015000, September 2007. This report is being transmitted to the NRC for information only. The information in BWRVIP-87, Revision 1, is used to support the BWRVIP Integrated Surveillance Program (ISP) as described in BWRVIP-86-A and BWRVIP-116.

This revision deletes the original fluence evaluation which has been superseded by the reevaluation reported in BWRVIP-128 that was transmitted to the NRC by the letter referenced above. In addition, the best estimate chemistry values and Charpy V-notch reference temperatures of some materials were updated to reflect analyses conducted since BWRVIP-87 was published.

Please note that the enclosed report contains proprietary information. A letter requesting that the report be withheld from public disclosure and an affidavit describing the basis for withholding this information are provided as Attachment 1.

Two (2) copies of the non-proprietary report "BWRVIP-87NP, Revision 1: BWR Vessel and Internals Project," EPRI Technical Report 1015000NP, September 2007, are also enclosed. This non-proprietary report is identical to the enclosed proprietary report except that the proprietary information has been deleted and the letters "NP" appear in the BWRVIP report number.

AFFIDAVIT

RE: Request for Withholding of the Following Commercial Document:

"BWRVIP-87, Revision 1: BWR Vessel and Internals Project, Testing and Evaluation of BWR Supplemental Surveillance Program Capsules D, G and H," EPRI Technical Report 1015000, September 2007

I, CHRISTIAN B. LARSEN, being duly sworn, depose and state as follows:

I am a Vice President and the Chief Nuclear Officer of Electric Power Research Institute, Inc. whose principal office is located at 3420 Hillview Avenue, Palo Alto, California ("<u>EPRI</u>") and I have been specifically delegated responsibility for the above-listed Report that is sought under this Affidavit to be withheld (the "<u>Report</u>"). I am authorized to apply to the U.S. Nuclear Regulatory Commission ("<u>NRC</u>") for the withholding of the Report on behalf of EPRI.

EPRI requests that the Report be withheld from the public on the following bases:

Withholding Based Upon Privileged And Confidential Trade Secrets Or Commercial Or Financial Information:

a. The Report is owned by EPRI and constitutes commercial information which has not been placed in the public domain by EPRI.

b. EPRI made a substantial economic investment to develop the Report and, by prohibiting public disclosure, EPRI derives an economic benefit in the form of fees charged for the sale of the Report. The Report is entitled to the protection of the United States copyright laws. If the Report was publicly available to consultants and/or other businesses providing services in the electric and/or nuclear power industry at no cost, these entities would be able to use the Report for their own commercial benefit and profit and without expending the substantial economic resources required of EPRI to develop the Report.

c. EPRI made a substantial investment of both money and employee hours over an extended period of time in the development of the Report. As a result of such effort and cost, both in terms of dollars spent and dedicated employee time, the Report is highly valuable to EPRI.

d. A public disclosure of the Report would be highly likely to cause substantial harm to EPRI's competitive position and the ability of EPRI to sell the Report both domestically and internationally. If a party does not purchase the Report from EPRI, it would require an investment of money, time and effort equivalent to that expended by EPRI for the party to duplicate the Report. I have read the foregoing and the matters stated herein are true and correct to the best of my knowledge, information and belief. I make this affidavit under penalty of perjury under the laws of the United States of America and under the laws of the State of California.




