Security

Benjamin W. Nerud

Culture of Security

- **Incorporate security into the culture of NRC and Agreement States**
 - **Focus on health, safety, and environmental protection**
 - **Security must have equal consideration**

Security Strategy

- **Three types of countermeasures provide full spectrum of protection from adversary**
 - **Affect the behavior**
 - **Affect the operational capability**
 - **Limit courses of action available**

Recommendation 1a

- **Suspend “good faith presumption” until a record of credible performance is established**

Recommendation 1a

- **For “new applicants” specific recommended actions include:**
 - **On-site visits to all licensed locations**
 - **Plans and procedures tailored to operation**
 - **Background investigations of key personnel**
 - **Requested materials comport with planned activities**

Recommendation 1b

- **Develop a process and establish criteria to allow recognition of new licenses as having a record of credible performance leading to establishment of trust**

Recommendation 2

- **Include licensing guidance in current NRC Operational Security Program**
 - **Exploitable information**
 - **Benefits of release**
 - **Measures to safeguard and control**

Recommendation 4

- **Develop detailed physical security standards using risk-informed, graded approach**
 - **Identify threats**
 - **Determine appropriate actions**
 - **Implement protective measures**

Recommendation 8

- **Re-evaluate pre-licensing guidance**
 - **Eliminate “good faith presumption”**
 - **Rely on on-site visits for verification**

Web-based Licensing and National Source Tracking System (WBL/NSTS)

Recommendation 3a

- **Integrate Web-based Licensing and National Source Tracking Systems**
- **Goal: real-time tracking of risk-significant sources**
- **Specific features for licensees and vendors**
- **A single system for NRC and Agreement States**

Recommendation 3b

- **Until the system is available, all licenses governing transfers of risk-significant sources should be verified**
- **Where trust has been established, exceptions could be considered**

Recommendation 3c

- **Develop and test system**
- **Involve Agreement States in development**
- **Plan rollout and implementation**

Recommendations 3 a, b, & c

- **Respond directly to the vulnerability identified in GAO report**
- **Provide a risk-informed response to the vulnerability**

Recommendation 5a

- **Incorporate security into culture of NRC and Agreement State licensing programs**

Recommendation 5b

- **Provide tools and training for making risk-informed licensing decisions**
 - **Threat awareness program**
 - **Investigation of suspicious applications**
 - **Information management databases**

Recommendations 6 a & b

- **Office of International Programs should follow Recommendation 1**
 - **Increased review for first-time import/export applicants**
- **Importers and exports under General Licenses should use WBL/NSTS system when available**

Recommendation 7

- **Continue to encourage “as needed” possession limits**
 - **Approximately 10 percent of licenses do not have upper bounds on possession limits**
 - **Exclusions may apply to 10 CFR 35.100, 200, and 300 uses**
