Betsy:

I am resubmitting Adobe Acrobat pdf files containing the information originally provided to you in my previous Email. I tested them out to make sure that they are readable.

In response to your question below, you may want to review paragraph 2-5 of Army Regulation 600-20. Further, to clarify matters, the Assumption of Command orders gives the Commanding General the authority he needs to accomplish his mission requirements. This includes any funding that is provided for in his budget as it is provided to the command by Headquarters, Department of the Army through Army Command channels (i.e., the Army Materiel Command). The Commanding General of this command must manage millions if not billions of dollars as part of his annual budget, part of which he can allot to decommissioning if so required. The Statement of Intent so states that he will assure that funds will be available to address the decommissioning effort, if and when needed. He has the authority to request any additional funds necessary to perform his mission and he does so through Army Command channels to Headquarters, Department of the Army.

I hope that the above information is beneficial in answering any questions you may have.
