The purpose of this modification is to:

Obligate \$10,000, increasing the total obligation to \$15,000 and the total estimated (ceiling) amount of the contract by \$5,000.00 to \$15,000.00.

Accordingly, the following clause is revised as follows:

1. Section A.6 CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988) ALTERNATE 1 (JUN 1991), paragraphs (a) and (b) are revised to read as follows:

- (a) The total estimated amount of this BPA (ceiling) for the products/services ordered, delivered, and accepted under this BPA is \$15,000. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the BPA period provided such orders are within any maximum ordering limitation prescribed under this BPA.
- (b) The amount presently obligated with respect to this BPa is \$15,000. The Contracting Officer may issue orders for work up to \$3,000. The obligated amount shall, at no time, exceed the BPA ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this BPA. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
