Yesterday, I received the comments from our Office of General Council on the Environmental Assessment for this amendment. I returned the EA to OGC last night with their comments addressed, in order to obtain their concurrence. This morning, the lawyer with whom I have been dealing directed me to also obtain concurrence from the State of Texas, since the waste will be going there. I sent the EA to the Texas Department of Health this morning. I requested a very quick turnaround on their review, if at all possible. I believe that this will push out Federal Register publication about 2 weeks. Immediately upon the notice being published in the FR, I can issue the amendment. I'll be leaning on Texas this week to try to get their comments/concurrence ASAP.
