

The purpose of this modification is as follows:

1. To revise Subsection B. CONSIDERATION AND OBLIGATION to provide funding which increases the obligated amount by \$450,000.00 from \$6,616,231 to \$7,066,231. Of the \$7,066,231 obligated amount, \$4,905,599 are obligated for Task 1, \$2,080,632 are obligated for Task 3.1, \$50,000 are obligated for Task 4.1.2, and \$30,000 are obligated for Task 5.2.

Accordingly, the following changes are hereby made:

1. Section B, CONSIDERATION AND OBLIGATION, Paragraph (2) is hereby deleted in their entirety and replaced with the following [specific changes are identified in italics]:

- (2) The amount presently obligated with respect to this order is **\$7,066,231**. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

This modification obligates \$450,000.00 in FY'08 funds.

All other terms and conditions remain unchanged.

Except as provided herein, all other terms and conditions remain unchanged and in full force and effect.
