The U.S. Nuclear Regulatory Commission (NRC) intends to publish a proposed rule in the *Federal Register* that would amend Parts 20 and 32 of Title 10 of the Code of Federal Regulations to expand the National Source Tracking System (NSTS). The amendments would require licensees to report transactions involving the manufacture, transfer, receipt, disassembly, and disposal of nationally tracked radiological sources. The information from these transaction reports would provide the input for the NSTS and ultimately provide an historical account of each nationally tracked radiological source. Licensees would also be required to provide information on their existing inventory of nationally tracked radiological sources at the time the rule is implemented.

This proposed rule would apply to NRC and Agreement State licensees. Although this proposed rule imposes a new information collection requirement on licensees that possess nationally tracked radiological sources, we believe that this regulatory burden is justified because the NSTS is a critical part of the comprehensive radioactive control program for the radioactive materials of greatest concern.
