Notification of Company Name Change and Request to Revise Chapters 1 through 7, 10, and 11 of License Application SNM-42.

Gentlemen:

As part of the reorganization efforts within BWX Technologies, Inc., the Nuclear Operations Division (NOD) is being incorporated as Babcock & Wilcox Nuclear Operations Group, Inc., (B&W NOG). As part of this reorganization, all assets of NOD will be transferred to B&W NOG. These changes do not affect ownership or authorized activity under SNM-42.

At this time BWXT is requesting a revision to the facility license to incorporate the name change as well as submitting facility name change revisions to the license application.

BWXT is requesting withdrawal of the previous amendment requests dated June 20, 2007 (References 3 and 4). Additional administrative revisions that were submitted with these requests are also being resubmitted at this time. Enclosure 1 provides a detailed list of revisions and justification for the revisions. Enclosure 2 provides Chapters 1 through 7, 10, and 11 in their entirety.

A determination was made that Chapter 10, Decommissioning, of Enclosure 2 contains financial information of a type described in 10CFR9.17(a)(4) and should be withheld from public disclosure in accordance with 10CFR2.390. Enclosure 3 is the signed affidavit of Roger P.

Cochrane stating that the information that is being submitted is to be withheld from public disclosure in accordance with 10 CFR 2.390.
