- (1) extend the period of performance of Task Order No. 007 through **April 14, 2008**.

1. The last paragraph of OPTION FORM 347 - Order for Supplies of Services starting with "Task Order No. 007 shall be effective..." is DELETED entirely REPLACED with the following:

"Task Order No. 007 shall be effective February 12, 2007 through April 14, 2008, with a total cost ceiling of **\$105,652.00**. The amount of **\$97,828.00** represents the reimbursable costs, and the amount of **\$7,824.00** represents the fixed fee."
