Dear Sir/Madame:

EnergySolutions, LLC is requesting the termination of our US Nuclear Regulatory Commission Radioactive Materials license, 39-23004-01, as issued to 140 Stoneridge Drive in Columbia, South Carolina. Pursuant to License Conditions 9 and 10, this is a mobile Decontamination and Decommissioning (D&D) license which was implemented at temporary job locations in order to perform D&D activities at a client site. No radioactive materials were transported, procured or possessed by EnergySolution at a fixed facility. In accordance with Condition 10(c), any materials that resulted from D&D activities were either transferred back to the client or shipped to a licensed disposal facility using a general licensed transport once the activities authorized by this license were complete. Any temporary job site remained in the client's possession.

In addition, all licensee-owned calibration sources and reference standards were either disposed or transferred to other active radioactive materials licenses managed by EnergySolutions.
