The purpose of this modification is to: (1) provide incremental funding in the amount of \$50,000.00, thereby increasing the obligated amount from \$661,700.00 to \$711,700.00, and to (2) acknowledge issuance of the attached Work Order: 010 – Beaver Valley, Units 1 and 2. Accordingly, the contract is modified as follows:

Under Section B.4, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUNE 1988), Paragraph (b) is modified as follows:

(b) The amount presently obligated with respect to this contract is \$711,700.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

All other terms and conditions of this contract remain the same, including the contract ceiling amount of \$936,676.15.
