This is in reference to a recent audit NRC conducted on your financial assurance for decommissioning for Nuclear Regulatory Commission License No. 20-08361-01. We have noted some corrections and additional information that is needed on your financial assurance documents for your license as follows:

1. Please indicate each location of use of byproduct material on your Statement of Intent rather than just referring to the facilities authorized under the Department of Health and Human Services.
2. Please revise your Certification of Financial Assurance statement to indicate Thorium 229 and Ni-63 sealed sources as is authorized on your license.
