Dear Ms. Moore:

This letter is in reference to your submittal dated April 20, 2007, to amend Part 1, Chapter 2 of Materials License SNM-124, with a revised Configuration Management program. The amendment request was supplemented by your December 14, 2007, response to a Request for Additional Information. It is noted that this amendment request is a requirement of a Confirmatory Order dated February 21, 2007.

Pursuant to Part 70 to Title 10 of the Code of Federal Regulations (CFR), Materials License SNM-124 is hereby amended to approve the revised Configuration Management Program.

Safety Condition S-1 has been revised to include the dates of April 20 and December 14, 2007.

Safety Condition S-53 for compliance dates has been added to read as follows:

S-53: For existing processes (designed, installed, or in operation prior to June 30, 2008) the Configuration Management program will be applied in accordance with the following schedule: (1) apply throughout BLEU Prep Facility - September 2008; (2) apply throughout Navy Fuel Operations - June 2009; (3) apply throughout NFS - December 2010.

All other conditions of this license shall remain the same.

By approval of this amendment request, TAC L32632 will be closed.
