Sommers) on April 3, 2008, the NRC staff agreed to a thirty-day extension for Dominion to submit the three-month response in order to address evolving positions on the required walkdowns. This letter is to confirm the agreement between the NRC staff and Dominion to delay submission of the three-month response until May 11, 2008.
