Gentlemen:

This letter is to provide clarifying information regarding the submittal of Amendment 6 (reference 2) to Wolf Creek Nuclear Operating Corporation's (WCNOC) License Renewal Application (LRA) provided by reference 1.

Reference 1 provided Wolf Creek Nuclear Operating Corporation's License Renewal Application (LRA) for the Wolf Creek Generating Station (WCGS). Subsequent to submittal of a LRA, 10 CFR 54.21(b) requires that "Each year following submittal of the license renewal application and at least 3 months before scheduled completion of the NRC review, an amendment to the renewal application must be submitted that identifies any change to the Current Licensing Basis (CLB) of the facility that materially affects the contents of the license renewal application, including the FSAR supplement."

Reference 2 submitted Amendment 6 of the WCNOC LRA "at least 3 months before scheduled completion of the NRC review" to satisfy the requirements of 10 CFR 54.21(b), however, it was not explicitly stated in the letter that that was the purpose of the submittal. Therefore this letter is being provided to identify that the requirements of 10 CFR 54.21(b) were met by the submittal of reference 2.
