**Please note that we have reformatted Subitem Nos. 6 and 7 Condition No. 12 at this time to remove all references to excluded authorizations, including but not limited to authorizations such as "generators, xenon-133, aerosols, cardiovascular clinical studies etc."**

**Please be reminded, however, that you and your Authorized Physician Users are still bound by the restrictions imposed by the excluded authorizations contained in documents incorporated into your license in Condition No. 15 of your license.**
