Re: Licensure Issues Pursuant to Change in Control

To Whom It May Concern:

Robert J. Accettola, M.D., LLC ("Transferor") is currently licensed by the Nuclear Regulatory Commission ("NRC") to operate equipment out of its office located at 3737 High Street, Portsmouth, Virginia 23707 (the "Office") pursuant to Materials License No. 45-25633-01. Pursuant to a Master Agreement (the "Agreement") dated effective as of January 1, 2008 (the "Effective Date"), Transferor sold its assets and assigned its material contracts to Lakeview Medical Center, Inc., a Virginia professional corporation ("Transferee"). The purpose of this letter is to provide the NRC with the information needed for a change of control of a licensed activity in accordance with the regulatory procedures set forth in the advisory materials entitled "Consolidated Guidance About Material Licenses," concerning the transfer of control or ownership of licensed activities and the requirements of NUREG-1556, Volume 15.

1. Transaction Description.

Prior to the Effective Date, Transferor operated as a medical practice for the purpose of providing the medical services to residents of Portsmouth, Virginia and the surrounding communities. Robert J. Accettola, M.D., ("Dr. Accettola") is the sole member of Transferor, which is a Virginia professional limited liability company. Transferee is a separately licensed entity by the NRC currently holding Materials License No. 45-25206-01.

Under the Agreement, (i) Transferor sold, assigned, transferred and delivered all right, title and interest of Transferor in and to its tangible business property to Transferee and (ii) Transferee assumed all obligations concerning contracts material to the operation of the Transferor's medical practice. Transferor's lease for the Office terminated as of the Effective Date and the landlord entered a new lease for the Office, naming Transferee as the tenant. Dr. Accettola's employment by Transferor terminated as of the Effective Date, at which point he entered into an employment agreement with Transferee. Dr. Accettola currently practices medicine and renders professional

services on behalf and under the direction and supervision of Transferee. Lastly, Dr. Accettola purchased one-hundred fifty shares of the common stock of Transferee, making him a shareholder on a parity basis with Transferee's other current physician-shareholders. In short, Dr. Accettola continues to service the Portsmouth community in the same location with the same personnel in the same manner as he did through the Transferor prior to the Effective Date. However, the practice is currently operated in the name of the Transferee, which maintains control over the assets, personnel and equipment used in connection with the delivery of Dr. Accettola's services.

2. Changes in Personnel and Duties Relating to the Licensed Program.

There have not been, nor will there be, any changes in the personnel relating to the licensed program and their duties respecting the licensed activities have not changed since the Effective Date. The Radiation Safety Officer will continue to be Emanuel Stein, M.D.

3. Changes in Organization, Location, Facilities, Equipment or Procedures Relating to the Licensed Program.

As of the Effective Date, Transferee assumed the financial responsibility for the licensed program, which responsibilities include, but are not limited to, paying the annual NRC and Virginia licensing fees, decommissioning responsibilities, radioisotope procurement, leasing and/or repairing imaging and other radiation monitoring equipment, purchasing and maintaining medical supplies and performing such other acts as shall be necessary to maintain the existing radioactive license. The operation of the licensed activities will continue to occur at the Office located at 3737 High Street, Portsmouth, Virginia 23707. The procedures are being performed under the name of Transferee d/b/a Cardiac Diagnostic and Treatment Center in lieu of Transferor. Neither the location of the Nuclear Medicine Department, including Hot Lab and imaging equipment, nor the procedures performed at this facility has changed.

4. Status of Surveillance Program

All required radiation safety procedures, including surveys, wipe tests, and required quality control, are currently performed in accordance with NRC and State regulations. The program is in good standing with NRC and State agencies. No change in the status has or will occur, the program remains current with no interruption to daily operations or required monitors and quality control.

5. Transfer of Records Concerning Safe and Effective Decommissioning.

Transferee has assumed full financial responsibility of all decommissioning procedures and records of the license held by Transferor. The license, however, has not yet been terminated and should remain effective until such time decommissioning becomes necessary.

6. Description of the Proposed Licensed Program.

Transferee shall adhere to all constraints, conditions, requirements and commitments of the Transferor. Upon transfer to the Transferee, the licensed program will be identical to the Transferor's program previously licensed by the NRC. A description of the program is set forth in Materials License No. 45-25633-01 issued by the NRC on October 9, 2003, a copy of which is enclosed with this correspondence.




