1. Val was wearing her rescue alert button. She tells me she does not transfer alone.
2. Val tells me her wheelchair is in good working order.
3. Val has not registered with the special needs registry yet; information was given to her to complete this.
4. Val tells me she is not doing well with her diet and it is because her social security has been decreased so she can't buy the diet drinks she likes. She also says it is because she had her molars removed while in the SNF and the sockets are not healed up yet. She said she was exercising until a few days ago, but now with her fibromyalgia bothering her, she is in pain and doesn't want to take more pain medication.
5. Val does not have a back up attendant, but she reports she has ads posted. Val reports the girl she hired to stay nights with her quit after a couple days she did not like the work. The only person working for her is Wanda who stays with her 24/7 and gets paid for 40 hours per week through the waiver. Wanda will leave for short periods of time, like 2 hours. I told Val she needs to get additional help or I am afraid she is going to burn Wanda out and then she will have no help. Val has a CNA 3 mornings a week for 1 hour each visit, and a HH RN monthly.
6. Val is aware that her hours will decrease beginning 7/1/08.
7. Val told verbalized that she is aware she is not holding up her end of this agreement and will continue to look for help. I told her I would give her some time to find the help; otherwise she could not participate in the waiver as her safety cannot be ensured.
