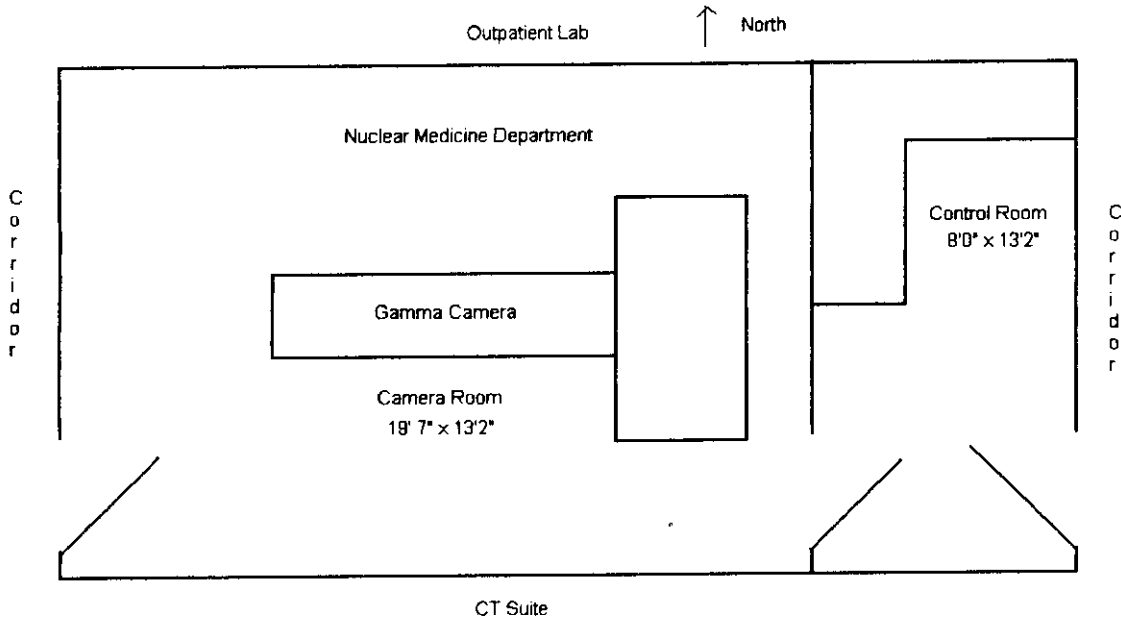

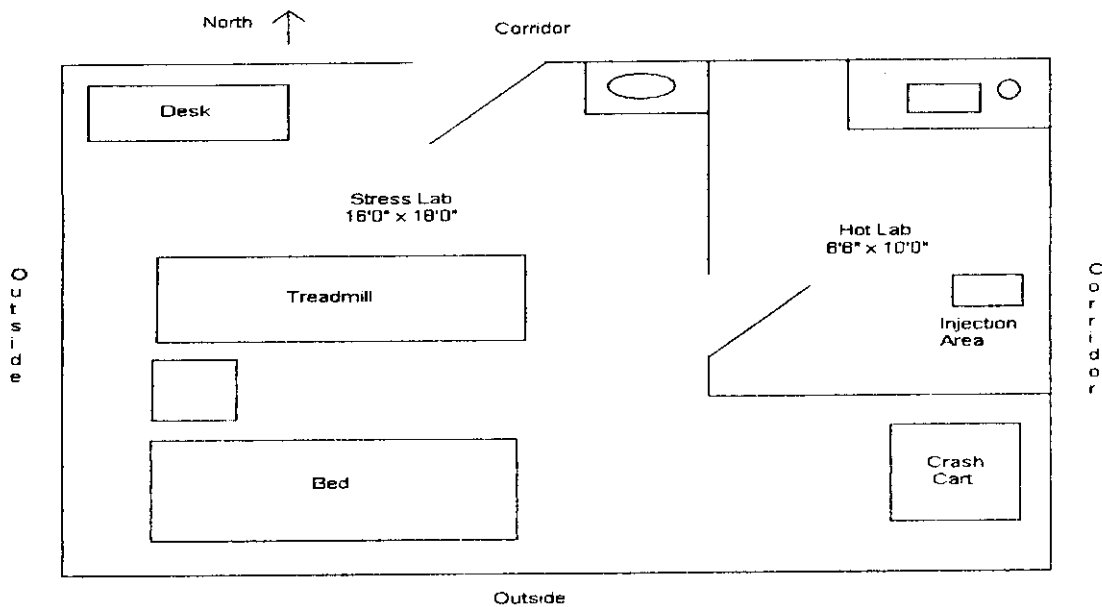
## Camera Room and Control Room



Directly below the nuclear medicine department is cement slab.

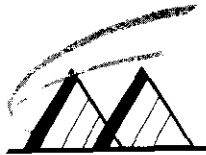
Directly above the nuclear medicine department are inpatient rooms.

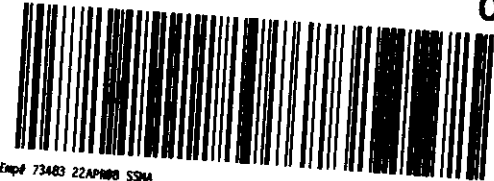
