The purpose of this modification is to extend the period of performance from April 15, 2008 to May 31, 2008 at a no cost extension to allow for verification of the systems operability prior to installation. This delay is a result of the NRC's Office of Information Services infrastructure review process. Accordingly the contract is modified as follows:

Under Section F.4 "Duration of Contract Period (Mar 1987)" is deleted in its entirety and revised as follows: "This contract shall commence on January 11, 2007 and will expire on May 31, 2008"

All other terms and conditions of the subject modification remain unchanged including the contract ceiling of \$735,470.57.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
