Dear Mr. vonTill:

This letter replaces a previous letter, same subject, dated March 6, 2008, which was addressed in error to Mr. Paul Michalak.

There are minor changes to the previous letter in that the portion of Tract 117 lies to the east of Strabane Avenue rather than to the west, as stated in the letter. As per a telephone discussion with Mr. Ron Linton, NRC, we will not resend the unchanged enclosures. The original text is hereby provided, with appropriate modifications.

The draft Long-Term Surveillance Plan (LTSP) has been revised to include NRC's proposed changes. The LTSP has also been updated to include information about the installation of new fencing in 2007 and the latest ground water monitoring analysis results.

In a letter dated March 23, 2007, to Mr. Keith McConnell of your office, we requested your concurrence to sell the portion of Tract 117 that lies east of Strabane Avenue. At that time, NRC raised concerns about differences in the LTSP and the deed for Area C concerning DOE access to the stream bank adjacent to Area C. Now, with the inclusion of the easement for Area C, we again ask your concurrence to sell that portion of Tract 117 with the provision that DOE access to the stream bank be included in the sales agreement.

Please provide your concurrence with the revised draft LTSP and with the sale of the portion of Tract 117, east of Strabane Ave.
