The United States Nuclear Regulatory Commission (NRC) has inflected an ORDER to suspending the operating license and Intervener process on the proposed South Texas Nuclear Project Units 3 & 4 adjacent to the existing Units 1 & 2 near Wadsworth, Texas.

The suspension is a delay in the engineering and construction progress; a curtailment in the much needed domestic and industrial generated electrical power, deregulated cost and jobs in our county.


Dear A. T. Byrdsong:

Dear NRC Attorney Biggins: I read in today's newspaper that the NRC has approved the foreign design of the STP Units 3 & 4. So, why has NRC Project Manager George F. Wunder, Sr, identified that the NRC staff has suspended the majority of its review of the safety part of the STP combined licensed application and postpones the public's opportunity to petition for leave to intervene by an ORDER of the NRC?

A STP spokesman said the two reactors will be on line by 2016.

Does this mean that STP knows something that the NRC doesn't? Or is it that the NRC doesn't want any interferer to have a say in the safety report?




